demands that may arise from an infection for CoVid-19, which includes the infection of a third
party unaffiliated with BSC or Hanover Township, Northampton County, Pennsylvania. I will not
hold BSC or Hanover Township, Northampton County, Pennsylvania liable for any consequences
from my or my child's participation in organized soccer under the CoVid-19 global pandemic,
including the selection of guidelines and procedures for participation in organized soccer.
For the purposes of this Acknowledgement, Waiver, Indemnification and Assumption of Risk,
CoVid-19 shall mean the disease state known as CoVid-19 or any related or mutated progeny of
CoVid-19 or coronavirus generally.
